Every day, we receive wonderful remarks about the great work of the Neighborhood Councils. I am sharing recent remarks shared by John F. Szabo, the City of Los Angeles's Librarian of the Los Angeles Pub and head of the board of Online Computer Library Center.

"I wanted to reach out to let you know of a delightful experience I had with the **Voices NC**. We have been soliciting public input for the dedication of the Vermont Square Branch Library to former City Councilmember Rita Walters. I was quite impressed with how the meeting was run, the transparency of making information available in chat and on their webpage, and their facilitation of public input. It was a lovely exercise in democracy and public participation."

# Department Administration

## **Planning 101 Training Update**

Thank you so much to the many Neighborhood Council Board Members and Planning & Land Use Committee members for completing the Planning 101 training.

If you are a current member of a Neighborhood Council Planning & Land Use committee member and haven't yet taken the Planning 101 - Project Planning training, the Department of Neighborhood Empowerment is extending the deadline to complete this training to August 1, 2021.

This training is a requirement for NC Land Use Committee members (or for an entire board, for those NCs without Planning & Land Use Committees) per the Board of Neighborhood Commissioners' NC [Leadership Orientation policy](#).

The Planning 101 – Project Planning training will be available on the Cornerstone platform in the coming months. Currently, the training is not available anywhere until then. We will make an announcement when it is available.

Once it is available, we will assign the training to all PLU Committee members that have been submitted to us at [rosters@empowerla.org](mailto:rosters@empowerla.org). Please be sure to complete the Planning 101 training by August 1, 2021.

Furthermore, many NCs who do have Land Use Committees have nevertheless added language to their standing rules that requires their entire board to take these Planning 101 trainings. This is a best practice because it helps strengthen the ability of all board members to review land use cases that come before them, and to write Community Impact Statements (CIS) on land use matters that have maximum impact.

## **Board Member Suspensions - Profiles**

As you know, for the past year the Department has successfully worked with Boards and Board Members to ensure compliance with the mandatory trainings required of Neighborhood Council board members. Our approach is and continues to be providing guidance and assistance as needed.

Upon our bi-monthly review of our training records, we see that some Board Members have been out of compliance for longer than 30 days of their Code of Conduct expiration date. It may also be possible that we do not have information to support that they have completed the Code of Conduct agreement, including their signature, as of 30 days of receiving their Cornerstone Board Member Training Portal login credentials. Pursuant to the Code of Conduct Policy, these Board Members have been notified that their status has been suspended. While suspended, they cannot act on any matter that comes before your Neighborhood Council and cannot be counted for the purpose of establishing a quorum of the Neighborhood Council. They have 30 days from the date of their notice to submit their signed Code of Conduct agreement in the Cornerstone Board Member Training Portal.

It is in the Department's interest to avoid the need to progress to the next step, which is to remove the board member from service on your Neighborhood Council. We are available to provide individuals with assistance in this regard. If their Code of Conduct is not submitted within 30 days of this notice, they will be removed from the board.

## City Clerk Funding

### **It's the 4th Quarter!**

We are now in the 4<sup>th</sup> and last quarter of the Fiscal Year. Please keep an eye on the following deadlines impacting use of your NC funds as we approach the end of the Fiscal Year:

- **May 20, 2021 - Final date to submit an Event Approval Request**
- **June 1, 2021 - Final date to submit a check payment request**
- **June 20, 2021 - Final date for any bank card transactions**

### **Rollover of Funds**

Please refer to Policy 1.1.3, Annual Budget Funds Rollover, in the [Policies and Guidelines Handbook](#) for more information on NC's ability to roll over funds at the end of the Fiscal Year. NCs are able to roll over up \$10,000 from one Fiscal Year to the next, on a non-cumulative basis. Non-cumulative means no more than \$10,000 may be rolled over and added each year to the City's annual budget allocation for each NC.

An NC is INELIGIBLE to receive rollover funds if any of the following apply:

- 1) In Exhaustive Efforts status as determined by DONE;
- 2) Funds are in "frozen" status, i.e., due to missing Monthly Expenditure Reports;
- 3) The current sitting Treasurer and Bank Cardholder are not in good standing per Program Policy

Please note that the ability of NCs to encumber funds authorized for last Fiscal Year is not available for this Fiscal Year. If there are any updates, we will notify you right away.

### **Election Transition**

As NC election season is underway, please work closely with your DONE Field Staff to ensure a smooth transition of power from the outgoing Board to the new Board. Please be aware of Board positions that are up

for election or may be continuing as this may affect your Financial Officers (Treasurers, Bank Cardholders, Signers), and your ability to access your NC funds.

Depending on your Board structure and election results, your NC may need to appoint new or re-appoint continuing Financial Officers at your very first meeting of the new Board. If necessary, our Office will work with you to process certain payments in a custodial manner, particularly office/operational expenditures as needed.

### **Election Expenditures**

Outreach is an important part of your election process to increase awareness and participation in your community. To this end, keep in mind that expenditures over \$5,000 may involve possible agreement with a vendor, which may take time to execute. As you plan your election outreach efforts, please be sure to work with your Funding Rep and vendors in a timely manner on election-related services that may involve agreements. This will ensure that election outreach to your community is done on time and not delayed by a possible agreement process.

## **NC Direct Support Operations**

As you know, the Department has successfully supported Neighborhood Councils during the COVID-19 pandemic by designing the trailblazing [Empowered Virtual Governance](#) system. A year ago, we purchased a one-year Zoom platform subscription to facilitate a smooth transition to virtual meetings. Once learning that the subscription was ending, and to avoid the NC System coming to an abrupt halt, the Department identified resources necessary to extend the Zoom licenses for all Neighborhood Councils in the System for one year. Additionally, we are excited to share that the [Roberts Rules Made Simple parliamentary procedures](#) license available for each board member has also been extended for an additional year!

### **Who is your new Neighborhood Empowerment Advocate (NEA)?**

You may have noticed that we began 2021 as we ended 2020 with a modification of our operating structures in order to respond to the impact of COVID-19 on the City of Los Angeles and its fiscal crisis. One of the impacts is the non-replacement of staff members leaving the department. During the last 12 months, four of our staff members left the Department and one is deployed as a Disaster Service Worker doing an amazing job related to Project Roomkey. Considering the size of our Department, you'll understand that any modification of our workforce has a direct impact on our operations.

We apologize if your Neighborhood Council has been impacted by recent changes and we want to make sure that we make the information available at all times. ## NC Outreach and Elections

Hello NC leaders,

We are in full gear with our election outreach efforts. We have been busy! Here is a link to our current outreach efforts: <http://tiny.cc/NCElectionOutreachReport>

Some highlights:

- In partnership with City Clerk, we had 8 Candidate info sessions with 1,109 sign-ups. That is a 363% increase from 2019 per session RSVPs.
- We connected with 70+ CBOs to see if they wanted to partner with our outreach efforts.
- 300,000 election postcards in 4 languages distributed at vaccine centers.
- 65 Election Outreach Strategy Sessions were held with individual NCs.
- 4 Regional Election Outreach Sessions were held for 8 Election Regions.

### Cut & paste voting overview to share with your voters

Here's some suggested language for explaining how to vote in this year's Neighborhood Council elections, which are entirely Vote-By-Mail for the first time. (Use this [timeline spreadsheet](#) to find the dates for your NC to fill in the blanks):

*Neighborhood Council elections are entirely Vote-By-Mail this year, due to COVID-19. **Ballots are postage-paid, but are only available by request.** Request your ballot on the City Clerk's website at <https://tiny.cc/VBMballot> by **[your NC's ballot request deadline]**.*

*Ballots must be postmarked by **[your NC's Election Day date]** or returned by that date in a local ballot drop box. Drop boxes are open from 9:00am the Friday before Election Day until 8:00pm on Election Day. Search for drop box locations near you at <http://tiny.cc/FindMyNC>.*

Take care of your voters: give them any other info they need to know in order to successfully cast their ballots, such as details on any voter eligibility documentation required by your NC.

Please join us at the upcoming Board of Neighborhood Commissioners meetings on Tuesday, April 6 at 6 pm and Monday, April 19 at 1 pm via Zoom. Topics to be discussed include updates on Department budget, staffing, other operational matters, and 2021 Neighborhood Council elections.

Thank you to the many Neighborhood Councils Board Members and stakeholders who have provided feedback, input, and comments regarding the proposed digital media policy. The Department is currently in the process of revising the proposed draft media policy. The revised draft of the proposed digital media policy will be on the agenda for the Board of Neighborhood Commissioners meeting on Monday, April 19 at 1 pm via Zoom.

On Tuesday, March 23, the Arts, Parks, Health, Education, and Neighborhoods Committee heard Council File 21-0182 motion authored by Councilmember Rodriguez, Ridley-Thomas, Koretz, Harris-Dawson) relative to the creation of the [Olivia Mitchell](#) Youth Council, which will include one male and one female young person per Council District who will serve one year terms. The motion passed unanimously 3-0 and will be going to the full City Council soon.

### **How to Request a NC Ballot**

Beginning 60 days prior to Election Day, stakeholders can submit a VBM Application using the new Vote-By-Mail Portal to request a NC ballot. Applications are reviewed to ensure stakeholders meet the NCs' voter requirements, and once approved, ballots are mailed to the voters. Voted ballots can be returned by mail using the postage-paid envelope provided or dropped in a ballot drop box by Election Day. The deadline to submit a VBM application is seven (7) days prior to Election Day. NC ballots must be postmarked by Election Day and received no later than ten (10) days thereafter.

**Note:** Applications or required documentation must be submitted no later than 5:00 p.m. on filing deadline days.

### **County VBM Ballot Drop Boxes**

The Office of the City Clerk is partnering with the County of Los Angeles to use their Ballot Drop Boxes for the 2021 Neighborhood Council Elections. The agreement was established to provide voters with a location where their ballots can be dropped off at a secure location over a 5-day period. Ballot Drop Boxes will be opened at 9:00 a.m. on the Friday before the election and closed at 8:00 p.m. on Tuesday (Election Day). ### **Tally of NC Election Ballots**

On March 17, the City Clerk began live streaming the tally of ballots. Each region's ballot tally takes place on the 1st, 6th\*, and 14th days after Election Day, from 9:00 a.m. - 4:30 p.m. (hours vary and are contingent upon ballots received). The tallies are live-streamed via **Zoom**

ETHICS – All Board Members are bound by California State Law to take Ethics Training every two years. The Ethics Training is required for all Board Members.
